The fine and court costs for offenses not set forth below may not be paid before the hearing date in court and the Defendant's appearance in Court <u>is</u> required.

## OFFENSES THAT CAN BE PAID PRIOR TO COURT

If you desire to plead guilty and do not wish to appear in court for the following offenses, which are listed with the total fine and court costs, you may follow the listed procedure.

Once the case is available on Case.net, for tickets you wish to plead guilty prior to the court date and pay the fine and costs, please refer to the Fine Schedule and follow these steps: Sign your name to the "Appearance Plea and Waiver" on the back of your ticket AND Pay your fine in full by:

- Sending a money order or cashier's check payable to: Boone County Circuit Clerk 705 East Walnut, Columbia MO 65201;
- Paying online through www.courts.mo.gov; Select Make a Payment; Select Plead and Pay; Enter the Case number found on your ticket; Pay the amount listed.
